# ORGANIZATIONAL STRUCTURE

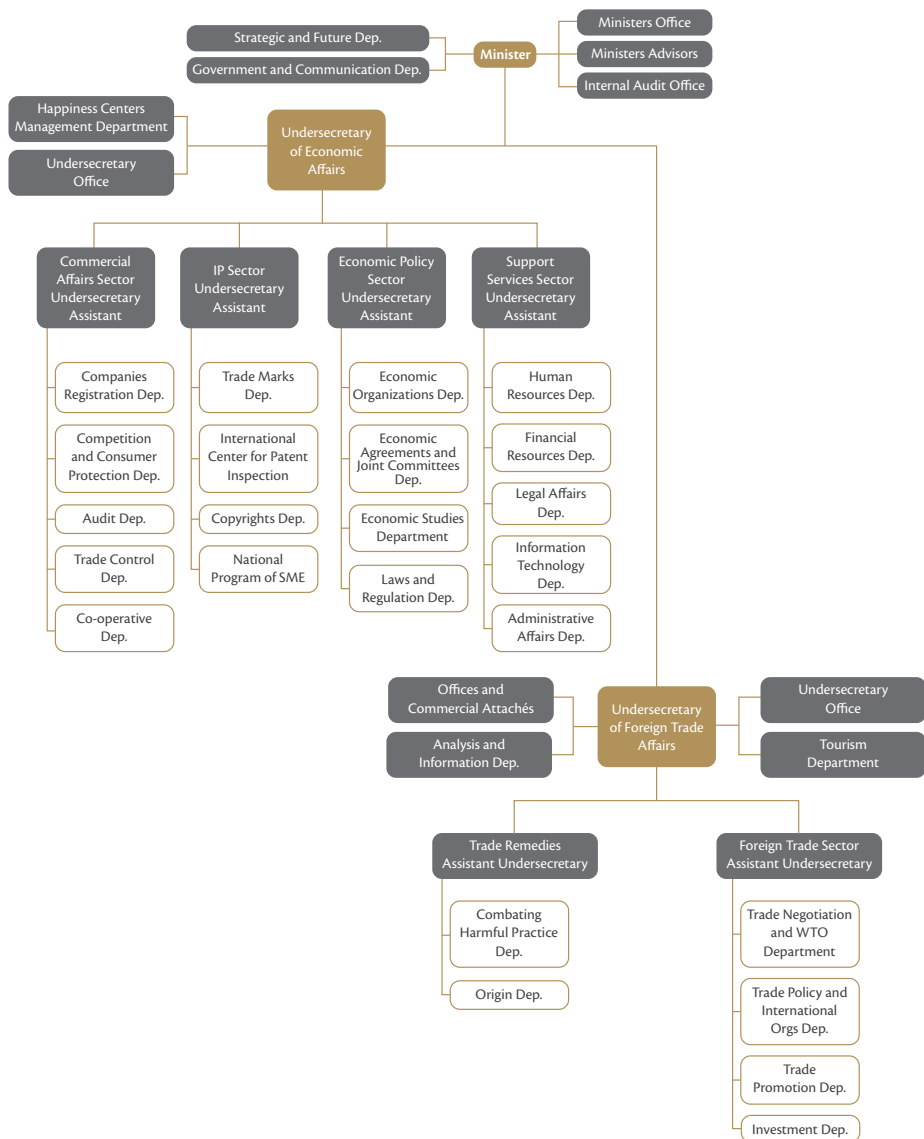

The foreign trade sector deals with trade policies and international organizations, including the World Trade Organization and the United Nations Conference on Trade and Development "UNCTAD". The sector carries out the tasks of commercial promotion for domestic products through supervising the plans and programs of trade fairs inside and outside the State, and works to explore new markets for the UAE exports, promote them, and direct exporters to upscale the efficiency of export. The sector also performs the tasks of managing and encouraging foreign investment by securing an investment-attractive environment and eliminating the difficulties facing investment projects, including working to unify and simplify registration and licensing procedures of projects, and providing support and advice to foreign investors. The sector prepares reports and publishes data regarding non-oil foreign trade and investment information.

## 1. Non-Oil Foreign Trade Developments

The Total non-oil foreign trade recorded an increase of 4.8% in 2019, to reach AED 1,705.5 billion. This increase was the result of higher non-oil exports (13.3%), re-exports (7.3%), and merchandise imports (1.5%).

### 1.1 Non-oil foreign trade classified according to the main partners in 2019

China was the UAE's first trade partner in non-oil foreign trade, with a total value of AED 183.9 billion, which is 10.8% of the total non-oil foreign trade in 2019. India came second with 8.9%, then Saudi Arabia 6.6%, while the GCC trade together accounted for 15% of the total non-oil foreign trade.

## 1.2 Non-oil exports in terms of UAE's main partners of 2019 (AED billion):

KSA was the UAE's first non-oil foreign exports destination for the second successive year in a row, accounting for a percentage of 12.9%, followed by India in second place, with approximately 10% of the total non-oil exports, followed by Switzerland in third place with 8.7%. The GCC jointly accounted for approximately 26.3% of the total non-oil exports.

## 1.3 Main re-exports partners of 2019:

The value of re-exports to KSA increased by AED 9.1 billion to reach AED 57.2 billion, accounting for 11.1% of the State's total re-exports in 2019, compared with 10.1% in 2018. KSA maintained its top place as a destination for the State's export for the second consecutive year. The value of re-exports to the GCC States reached 23.6% of the total re-exports. Iraq came in the second place as a destination for re-exports with 8.0% of total re-exports, and India in the third place with 5.8%.

### 1.4 Main Imports partners in 2019:

China remained the most important imports partner in 2019, accounting for 15.7% of total imports for the year 2019, compared with 14.9% for the year 2018. Followed by India with 10.3%, and the USA with 7.7%. The GCC States accounted for 7.5% of total imports.

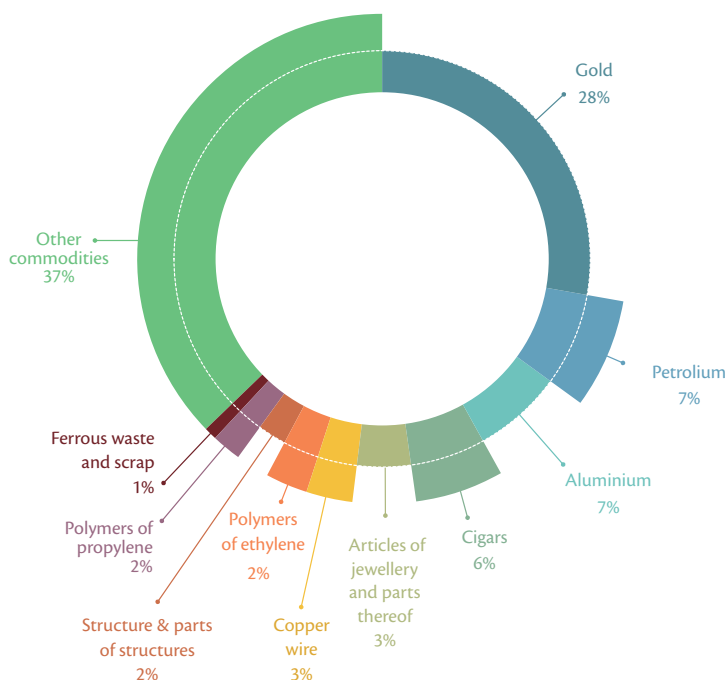

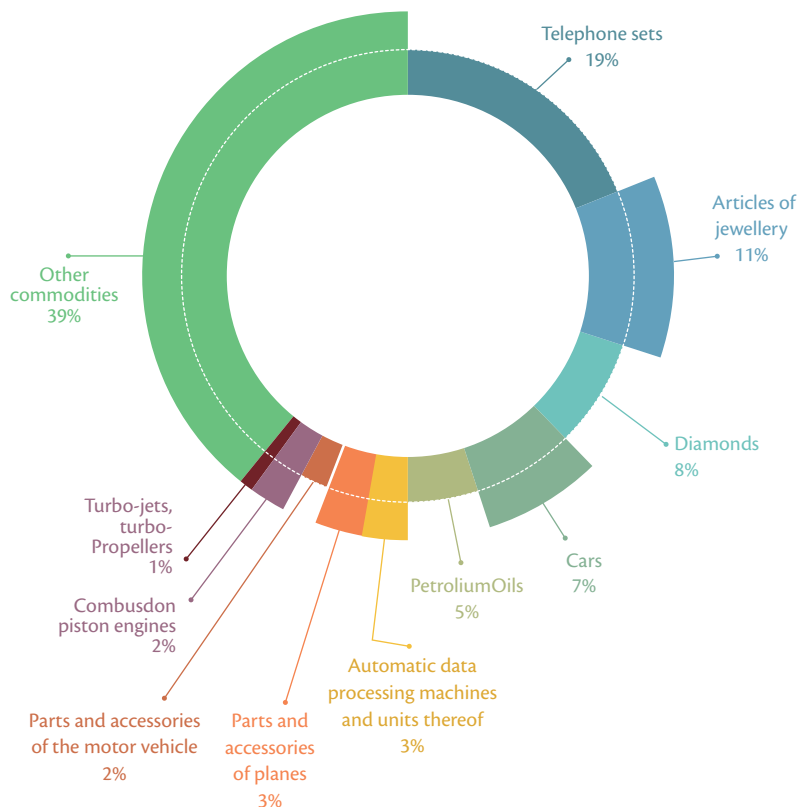

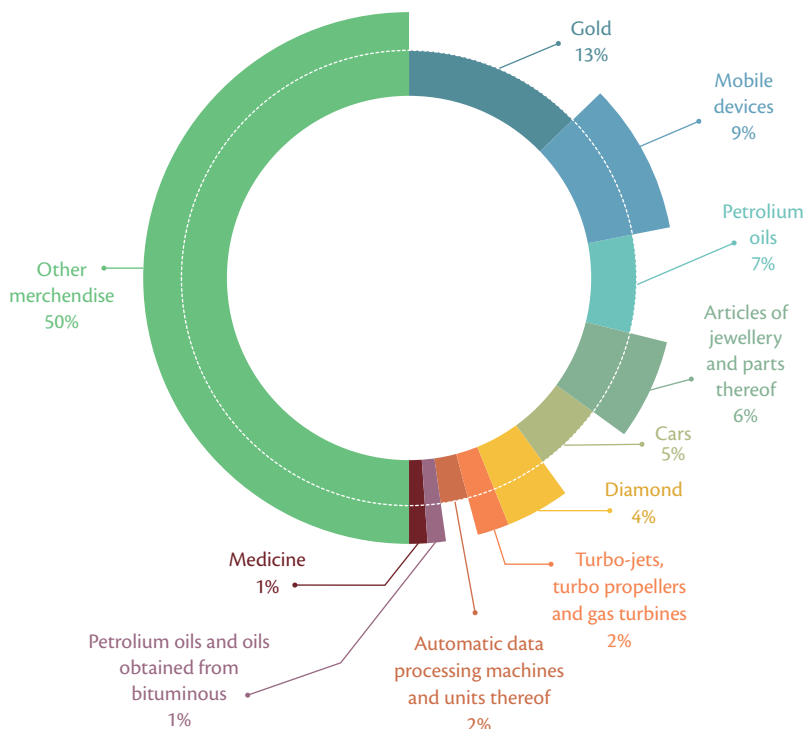

## 2. Foreign Direct Investment Developments

### 2.1 UAE's Foreign Direct Investment Inflows in 2019

- The value of foreign direct investment inflows to the UAE increased during 2019 by USD 3.4 billion (AED 12.9 billion), by a percentage of 32%, driving the UAE to advance 3 ranks to hit the 24<sup>th</sup> position globally in 2019. The total inflow of foreign investment to the UAE in 2019 reached a total of USD 13.787 billion (AED 50.6 billion) compared to USD 10.385 billion (AED 38.1 billion) in 2018.

- The UAE ranked first on West Asian states in terms of foreign direct investment inflows, accounting for 49.4% of the total inflow of foreign investment into West Asia.
- The UAE ranked first on MENA region, with about 31% total share of the foreign investment inflows to the region in 2019.

## **2.2 Total cumulative foreign direct investment inflows**

- The total cumulative foreign direct investment inflows to the UAE increased by 10% compared to 2018, reaching USD 154.107 billion (AED 566.03 billion) in 2019 compared to USD 140.320 billion in 2018.

## **2.3 UAE's inward foreign direct investment stock in 2019**

- The UAE has maintained its 19<sup>th</sup> position globally in the total inward FDI stock of the UAE to the world inward FDI stock reached a total of USD 15.901 billion in 2019 compared to USD 15.079 billion in 2018, an increase of 5.5% compared 2018.
- The UAE ranked first in the MENA region, with about 43% share of the total foreign direct investment inward stock of the MENA region in 2019; a value of USD 37.139 billion.

## **2.4 Total outward foreign direct investment stock**

- The total outward cumulative foreign direct investment stock increased by 11.4% compared to 2018, reaching USD 155.430 billion in 2019 compared to USD 139.529 billion in 2018.

## **2.5 Investment in greenfield projects**

- The value of foreign investments in green projects inside the United Arab Emirates grew by 54% during (2017-2019) to reach about USD 13.6 billion in 2019, while the UAE's investments in green projects abroad amounted to USD 14.9 billion in 2019.

## **2.6 Bilateral investment agreements**

- Around 22 international investment agreements were signed in 2019, and the UAE was the most active, with Australia and Brazil, with three new international investment agreements for each.

The intellectual property sector is concerned with managing trademarks and intellectual works and registering patents. The sector seeks achieving its objectives of organizing and protecting trademarks, creative thinkers, copyright and industrial property, as part of the ministry's general strategy. Therefore, it applies the federal laws in this regard and ensures a smooth progress of the work.

## 1. Trademarks

The Trademarks Department deals with organizing and protecting trademarks through the application of the federal law on trademarks, protecting trademark owners, receiving trademark registration applications, examining them, and following up procedures of advertisements, objections, and registrations; and the issuance of registration certificates, approving of renewals, amendments, cancellations, mortgages, transfer of trademarks, and licensing their usage according with the relevant prescribed regulations. The department also receives complaints and follows up on trademark-related cases with the competent courts, and issues a trademarks gazette, in addition to following up on international agreements and coordinating with international organizations specialized in trademarks.

### 1.1 Trademarks Department achievements in 2019

- Holding meetings, which reached 6 in number, with the federal authorities and the private sector with the objective of promoting the culture of intellectual property and explaining the mechanism of registering trademarks.
- Organizing introductory workshops for the management personnel, in cooperation with the World Intellectual Property Organization, on best practices in the field of intellectual property.
- Holding induction and training workshops about the government agencies' intellectual property.
- Participation in global initiatives, through its participating in the organization and coordination of the World Intellectual Property Day celebration in April 2019.
- Work on completing an amendment bill of federal law regarding trademarks.
- Launching a set of electronic services such as:
  - Objection service
  - Grievance Service
  - Trademark registration service
  - Attestation service
  - Certification service (To Whom It May Concern Certificate - Trademark Data Certificate - Copy of Registration Certificate)

### 1.2 Trademarks Statistics


#### 1.2.1 Key trademark indicators of 2019

The number of trademark registration applications filed reached 18,686 in 2019, with an increase of 231 applications compared to those in 2018. The number of national applications filed for trademark registration reached 5576 in 2019, accounting for nearly 30% of the total applications for trademarks filed.



As for foreign trademarks filed, the USA accounted for the largest share of the total trademarks filed, with about 17%, followed by China with 6% and France with 5%.

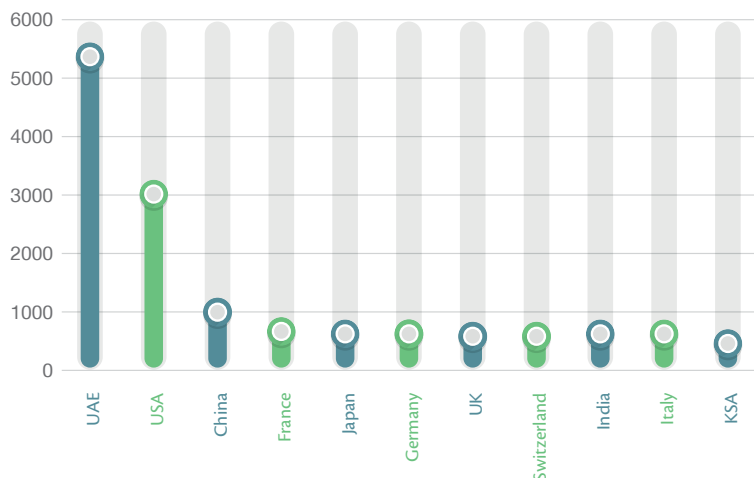

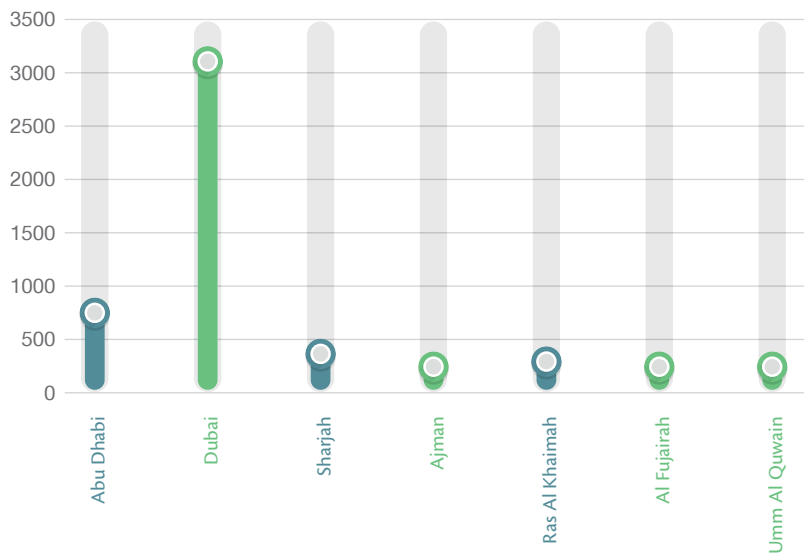

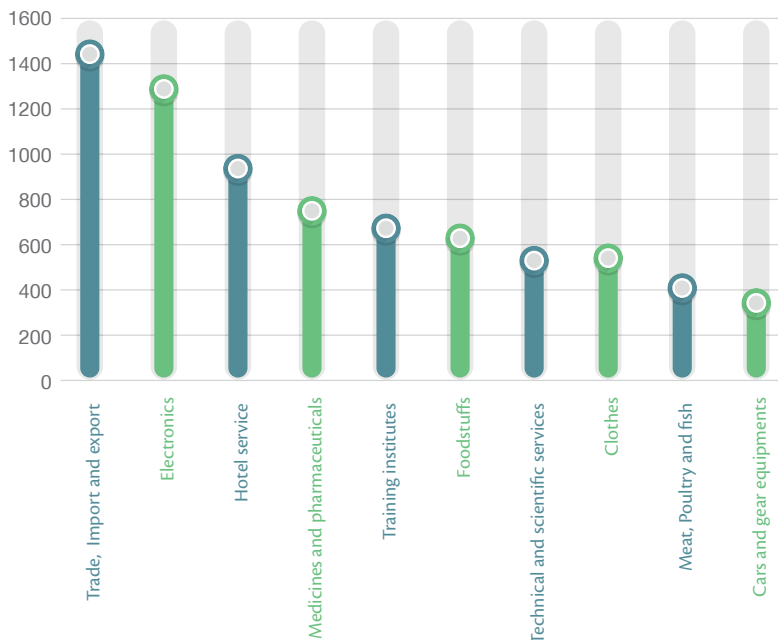

## 2. Intellectual Works

The Intellectual Works Department is concerned with the regulatory protection of creative authors the publishing and intellectual property rights through the application of the federal law on copyright and related rights, protecting creative people in accordance with the law, receiving property rights registration applications, and registering the intellectual works of natural and legal persons, as well as receiving complaints and following up cases in courts. It also communicates, participates, and coordinates with international organizations and bodies specialized in intellectual property, follows up on new legislation, maintains a database of intellectual works and classifies them.

## 3. Patents

International Center for Patent Registration is concerned with the regulation and protection of industrial property and scientific knowledge through the application of federal laws on the regulation and protection of industrial property and in implementation of international agreements such as the Paris Convention for the Protection of Industrial Property, the Patent Cooperation Agreement (PCT), TRIPS, and the patent system of GCC States; on patents, drawings, industrial models, scientific knowledge, and contractual licenses. The center receives applications for patents and industrial models, examines and issues their certificates, receives complaints and grievances related to patents, processes them in accordance with the law and follows up on cases before the courts. It also creates a database on global patents, organizes communication and sharing with the international patent documentation centers, publishes an industrial property bulletin, and contributes to technology transfer, in addition to coordinating and following-up with the international agreements in the field of industrial property.

### 3.1 The Agreements and Memorandums of Understanding Signed in 2019

- In February 2019, a Memorandum of Understanding was signed between the UAE Ministry of Economy and the Korean Intellectual Property Office on enhancing cooperation activities in the field of intellectual property.
- In June 2019, a Memorandum of Understanding was signed between the UAE Ministry of Economy, the Korean Intellectual Property Office, and the Patent Information Promotion Center in the Republic of South Korea on the commission of third competent authority for the purpose patents examination for the UAE.
- In June 2019, a contract was signed for recruiting an information technology expert to succeed the Korean expert, whose term on secondment at the Ministry expired in June of this year.



- In October 2019, a memorandum of understanding was signed between the UAE Ministry of Economy and the Korean Intellectual Property Office on cooperation to harness artificial intelligence in patent management and review the patentability of inventions related to artificial intelligence.

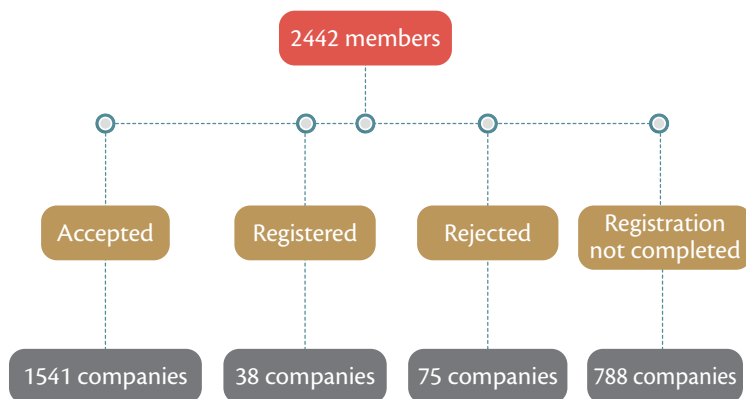
## 4. National Program for Small and Medium Enterprises

The Program was established under Federal Law No. 2 of 2014 under the umbrella of the Ministry of Economy. The Program is supervised by a specialized council affiliated to the Ministry which, aims to enable small and medium-sized National entrepreneurs and developing the general frameworks and guidelines that aim at providing the necessary expertise and the technical, administrative and training support in various fields in order to promote and develop small and medium-sized enterprises in addition to preparing periodic evaluations of them.

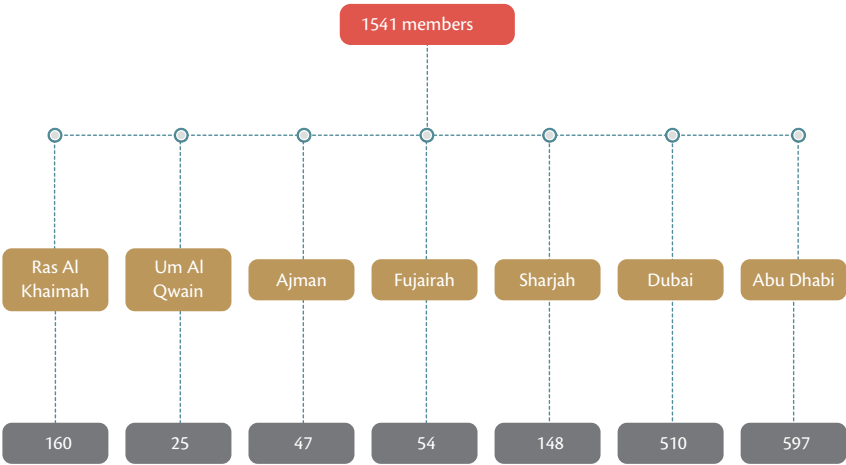

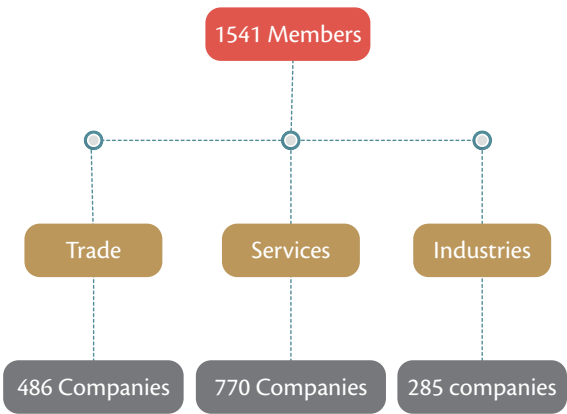
#### Number of the members of National Program for Small and Medium Enterprises in 2019

The commercial affairs sector in the Ministry of Economy is responsible for proposing commercial policies, setting, developing, implementing and following up all procedures related to commercial affairs, including policies and procedures related to company registration, commercial agencies, auditors, as well as following up the upgrading and implementation of procedures related to commercial control and consumer protection, and the provision of strategic stocks of food commodities, in addition to combating money laundering and funding terrorism.

Within the framework of the Commercial Affairs Sector's regulatory role in organizing the work of the State's economic sectors, in 2019, the sector worked on preparing (12) economic policies, which were submitted to the Cabinet. Among the most prominent of those policies:

- Amending Consumer Protection Law
- Issuing the implementing regulations of Commercial Anti-fraud Law
- Amending the Commercial Agencies Law
- The government's fees policy for improving the business environment
- The Cooperative Societies Law

**Moreover, some policies were approved by the Cabinet about:**

- Combating Money Laundering and the Financing of Terrorism and Illegal Organizations.
- Regulating procedures related to real beneficiaries.

Out of the Ministry's awareness of the important role of regulating electronic commerce and its tremendous growth, work was underway in 2019 for completing an integrated national policy on regulating e-commerce in the State and through the commercial affairs sector. A bill is expected to be submitted by the end of 2020.

In response to the requirements of the International Mutual Evaluation (FATF) on combating Money Laundering and the Financing of Terrorism, the Ministry prepared, through the Commercial Affairs Sector, all organizational and executive frameworks and workshops, 8 workshops in 2019, to explain, educate and circulate the legislations on combating Money Laundering and the Financing of Terrorism and Illegal Organizations. Moreover, 28 cooperation agreements were signed with local authorities and specialized free trade zones regarding the licensing and regulation of those issues. The Ministry's Commercial Affairs Sector held two meetings in 2019, within the framework of the "Economic Coordination and Cooperation" committee's role in coordinating and cooperating between the Ministry of Economy, the Ministry of Finance, the Central Bank of the Emirates, the Ministry of Human Resources and Emiratization, and the Departments of Economic Development in the UAE for proposing common economic policies in various fields, especially for contributing to the development of the business environment, investment, economic legislations and outlooking the future of the UAE economy.

# 1. Commercial Registration Department

## 1.1 Private Joint-stock Companies

The number of private Joint-stock companies registered at the Ministry of Economy recorded 162 companies by the end of 2019; with the number of Joint-stock companies in Abu Dhabi reaching 91 companies (56% of the total), While in Dubai 52 (32% of the total). The number of Joint-stock companies located in the other emirates recorded 19 companies (12% of the total).

Regarding to the distribution of private Joint-stock companies according to the economic sector, the Investment Sector accounted for 36% of the total number of companies, followed by the Water and Electricity sector with 16%, then the Real Estate and Finance Sectors with 14% for each, of the total private Joint-stock companies.

The total capital of the private Joint-stock companies in the State reached about AED 144.2 billion, of which Dubai accounted for 68%, Abu Dhabi 30%, and the rest of the emirates 2%.

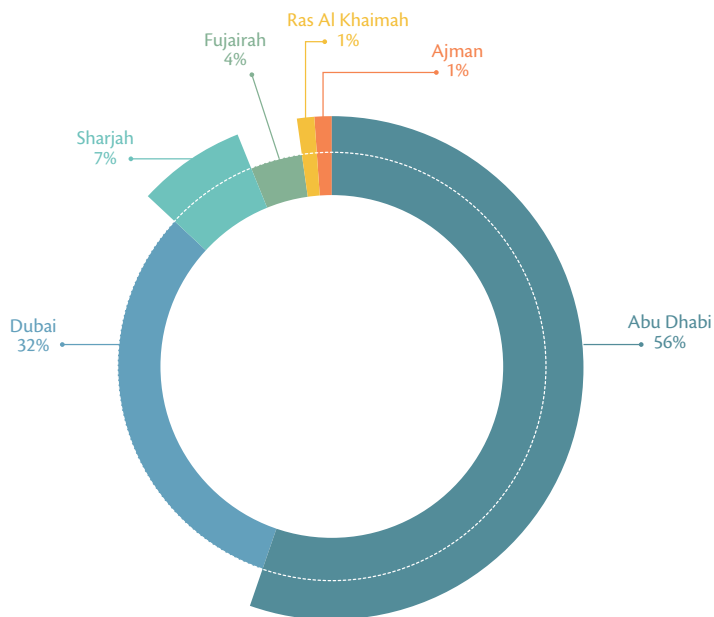

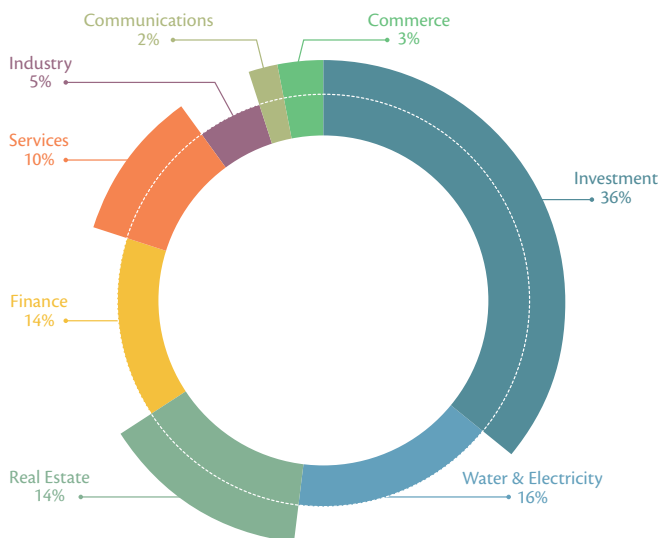
### Private Joint-stock companies distributed according to emirate 2016

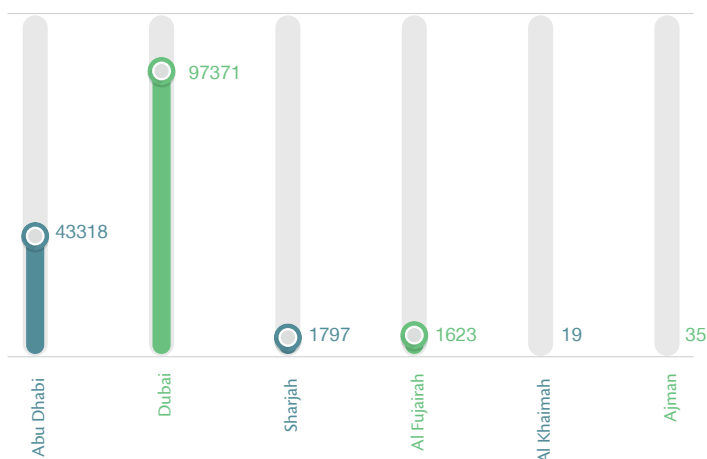
## Number of Joint-stock companies distributed according to the economic sector in 2019

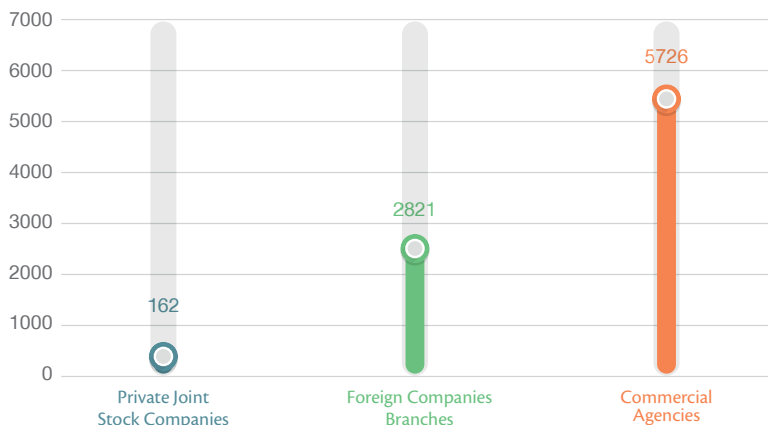
## Private Joint-stock companies' capital distributed according to emirate in 2019, AED million

### Number of private Joint-stock companies, private companies' branches and total commercial agencies in 2019



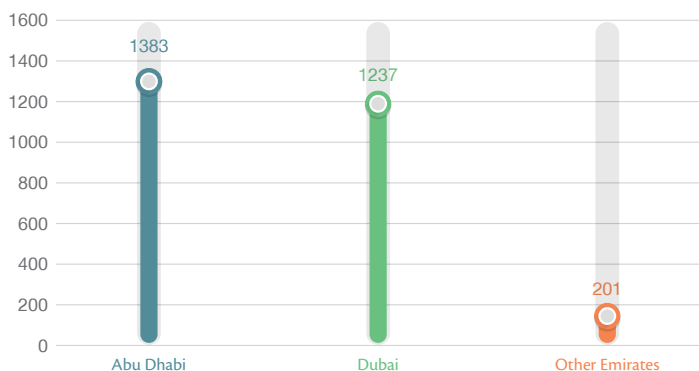

### 1.2 Branches of Foreign Companies

The number of branches of foreign companies reached 2821 by the end of 2019, mostly concentrated in the emirates of Abu Dhabi (49%) and Dubai (44%). Distributed by nationality, the English branches accounted for 12.4% of the total branches, followed by the American by 8.6%, and the Indian by 5.6%.

### Number of Foreign Companies' branches distributed by emirate in 2019



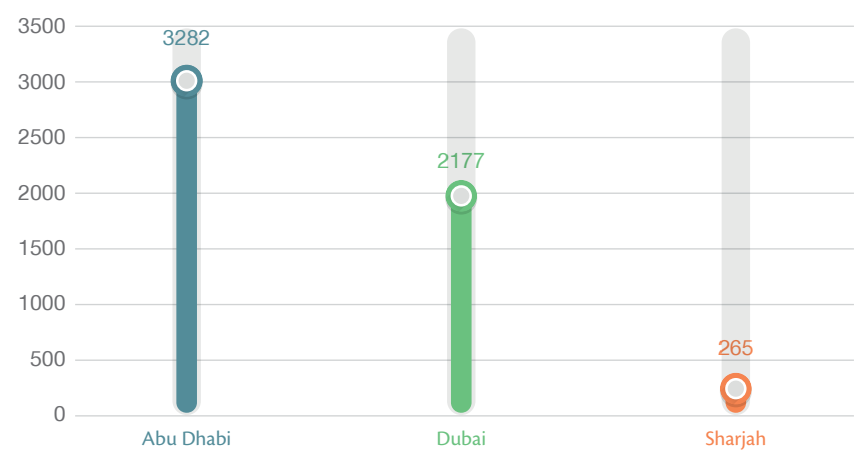

1.3 Commercial Agencies

The number of commercial agencies reached about 5726 by the end of 2019; 57% of them in Abu Dhabi, and 38% in Dubai. Distributed according to economic activity, the Engineering Equipment activity accounted for 30.8% of the total agencies, followed by the Medical Equipment activity by 18.8%, then the Firefighting and Safety equipment activity by 13.7%.

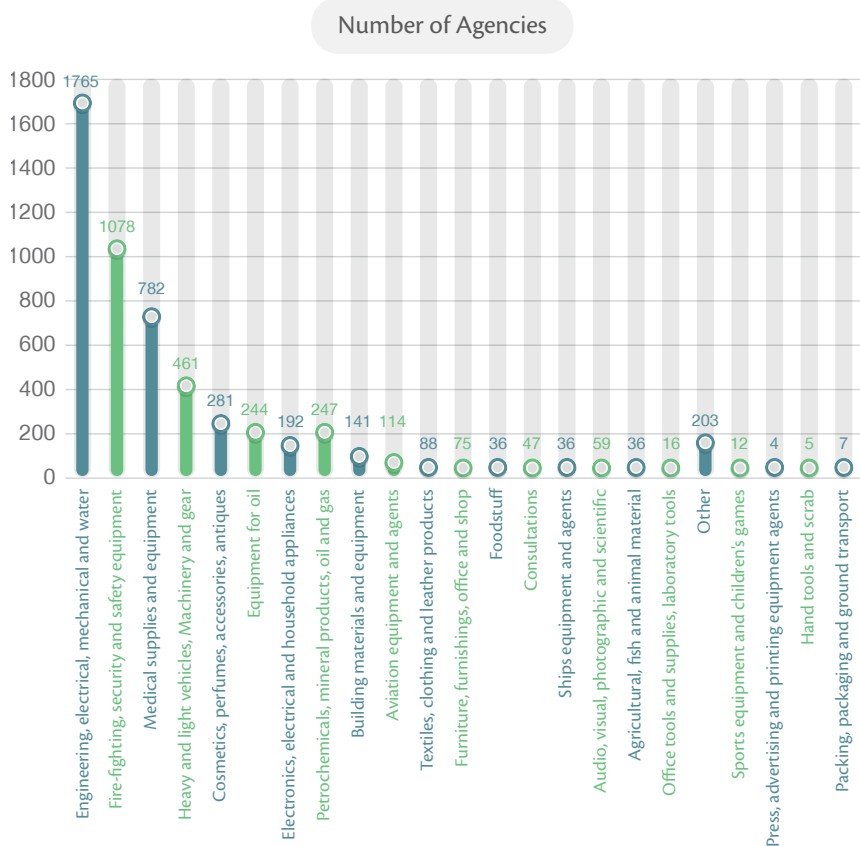
Chart 12 Number of total Commercial Agencies distributed by Emirate in 2019



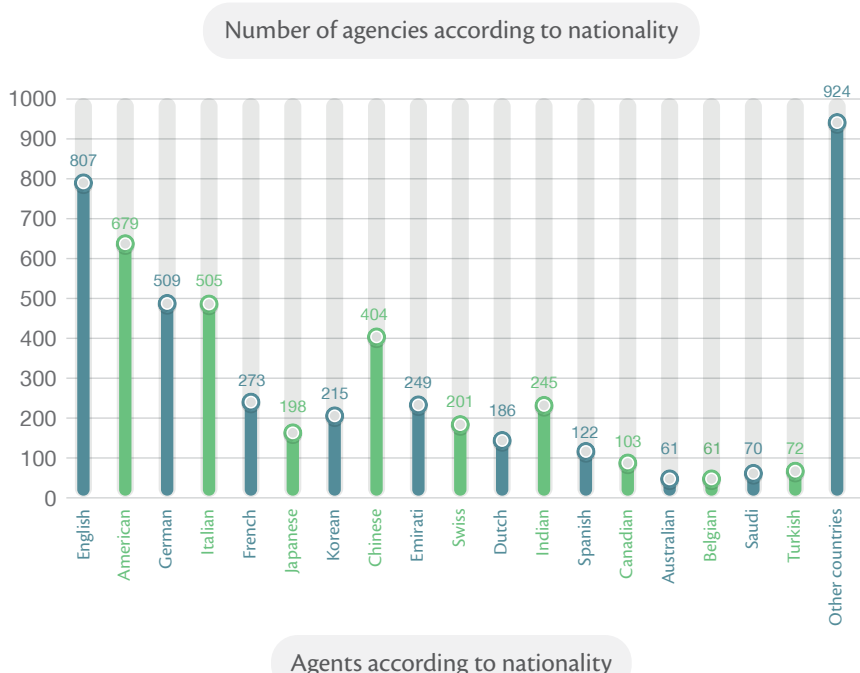

## 2. Competitiveness Consumer Protection Department:

The Consumer Protection Department supervises the implementation of the general policy of consumer protection, combats illegal commercial practices, monitors price movement, and works to limit their rise, in cooperation with the States' concerned authorities. It also coordinates and cooperates with the concerned authorities in spreading the awareness about the consumption of goods and services and educating the consumers about their rights and methods of claiming them, in addition to achieving the principle of fair competition and fighting monopoly. The department receives consumers' complaints and works to take measures regarding them or refer them to the competent authorities.

The number of consumer complaints decreased significantly, by 20% in 2019, down to 12,300 complaints, of which more than 95% were settled, compared to 15,346 complaints in 2018 and 15,978 complaints in 2017.

### 3. Cooperative Societies Department

The Cooperative Societies Department is responsible for advertising and registering the Cooperative Societies in accordance with the cooperative sector's relevant legislation in force. It also promotes the policy of Cooperative Societies, diversifies its fields and activities, and educates about the concept and principles of the cooperative economy, in addition to the administrative and financial supervision and oversight tasks for checking of Cooperative Societies' commitment to cooperative principles.

The number of Cooperative Societies operating in the UAE reached 41 societies in 2019. The Cooperative Societies were divided among the States' emirates, with the highest presence in Abu Dhabi (44% of the total societies); 18 cooperative Societies, 7 societies in Dubai (17% of the total societies), and the same number in Sharjah; 7 societies (17% of the total cooperatives), whereas the total number in the remaining emirates was 9 cooperative societies.


Distributed according to activity, the number of Cooperative Societies working in the Consumer Sector recorded 19 which is (46% of the total), and 13 societies working in fishing activity; (32% of the total). A small number of societies were working in other activities such as the Crafts, Housing and Rental Sectors.

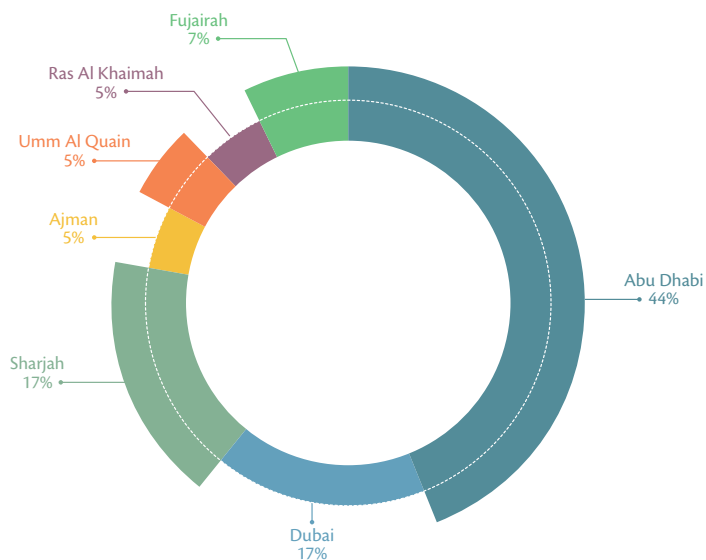

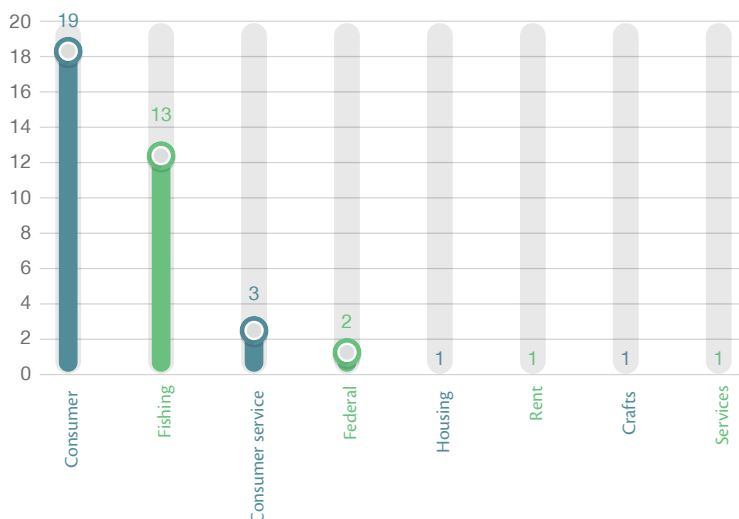
## Cooperative Societies in the UAE distributed according to emirate in 2019



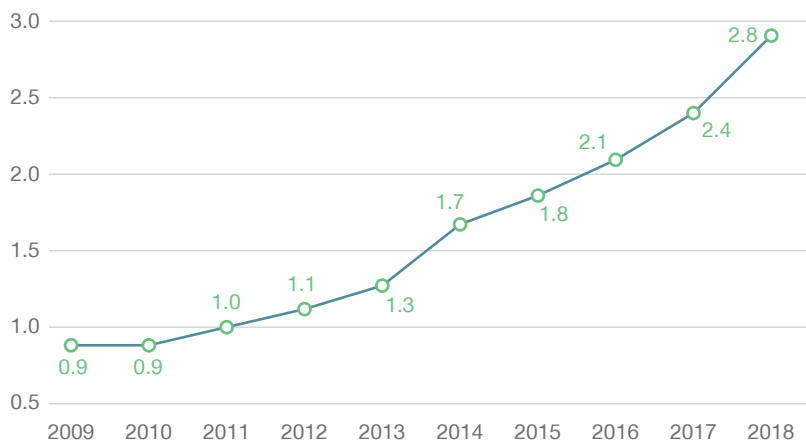

## 4. Commercial Control

The Commercial Control Department mainly monitors and follows up the implementation of the laws related to commercial control issued by the Ministry, and prepares periodic reports on that, while monitoring obstacles, of an economic nature, facing the practical application of legislations and executive regulations and discussing them with the competent authorities.

The total number of violations compared to the number of total inspection tours carried out by the Commercial Control Department decreased to about 7% in 2019 compared to 9.2% in 2018. This decrease came as a result of the decrease in the percentage of violations for all types of tours, as a result of the efficiency of inspection and the increase in the compliance with regulatory legislation. The percentage of violations related to consumer protection issues dropped to 12.8% in 2019, compared to 15.7% in 2018. The percentage of violations related to trademark issues dropped to 8.2% in 2019, from 9.6% in 2018. The percentage of violations related to Commercial Agency and Copyright decreased significantly to reach 6.7% and 1.4% respectively in 2019, compared with 32.3% and 11.4% respectively in 2018. As for commercial fraud cases, they maintained their low percentage of approximately 2.7 % in 2019, compared to 2.2% in 2018.

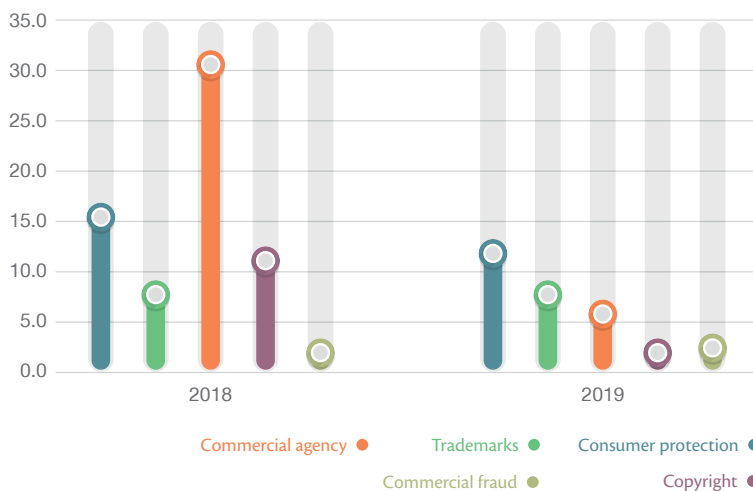

## 5. Auditors Department:

Auditors Department undertakes the task of registering and renewing the registration of practicing and non-practicing auditors whether natural and legal persons, and monitoring auditing offices to ensure their commitment to the laws regulating the profession of accounting and auditing and to professional performance standards, as well as receiving complaints on professional violations and forming committees to adjudicate them. The department undertakes setting the required legal framework for regulating the profession of auditing based on the legislations issued in this respect.

The total number of non-national auditors registered in the State was 1138 auditors in 2019, 685 of them are nationals. The total number of auditing offices was 144, of which 111 are local ones and 33 are branches of foreign offices.

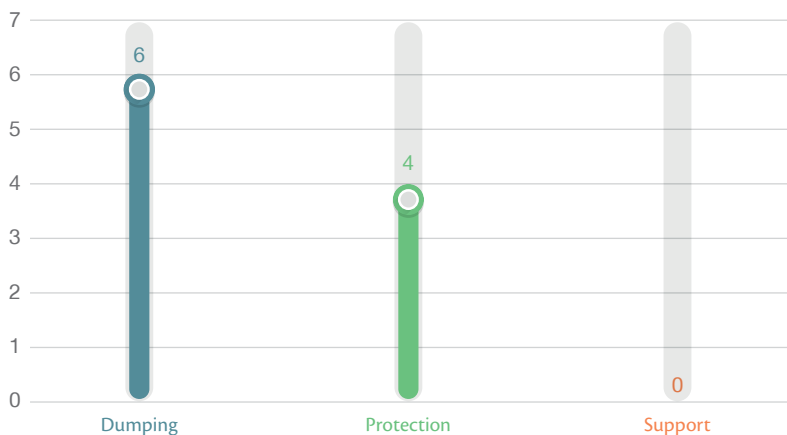

#### Distribution of investigations and complaints according to type in 2019

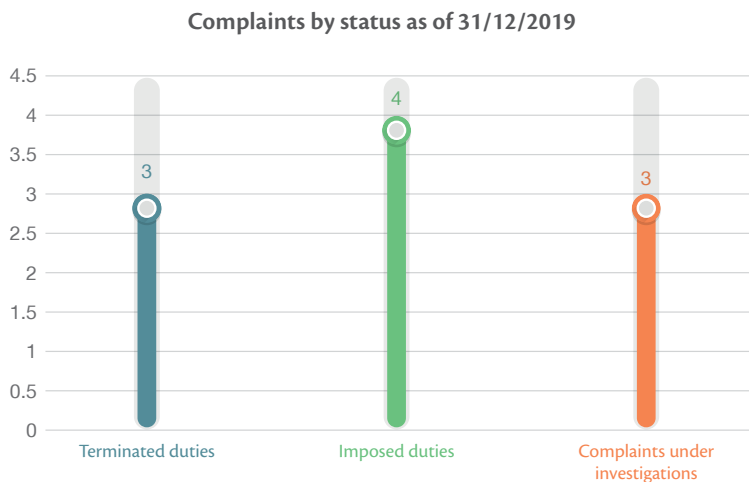
Distribution of investigations and complaints according to type as of 31/12/2019

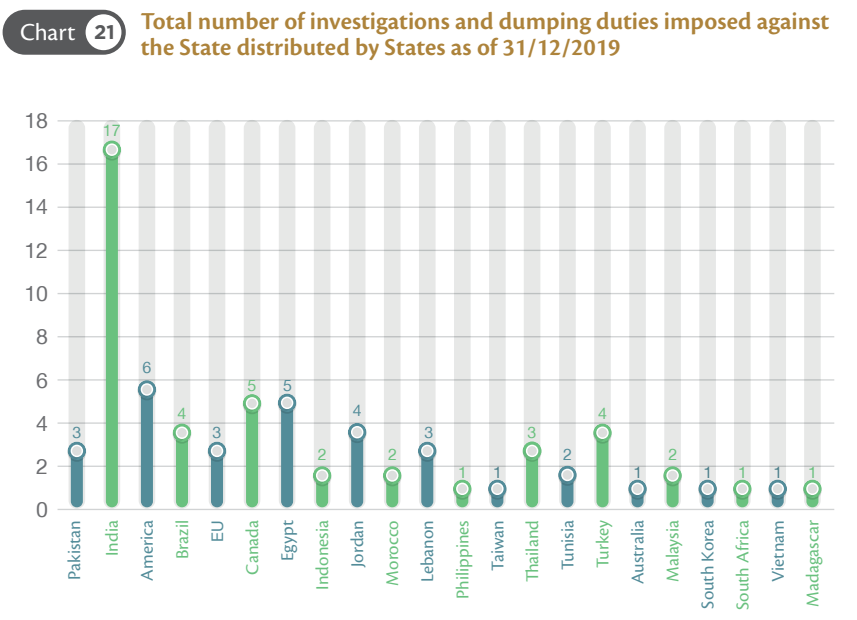

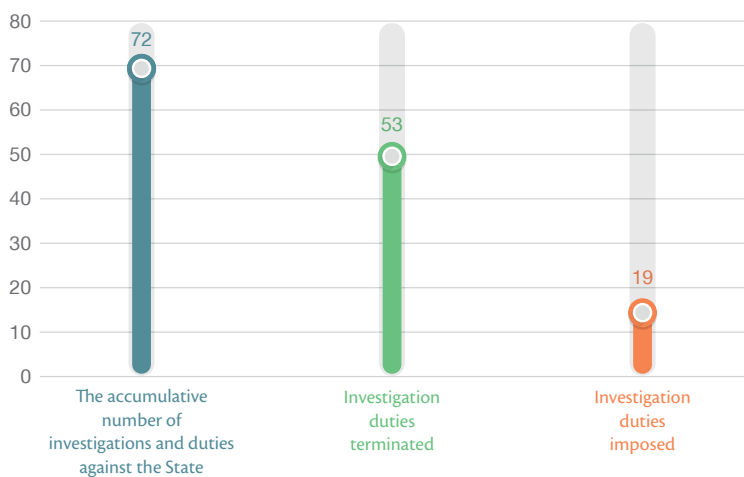

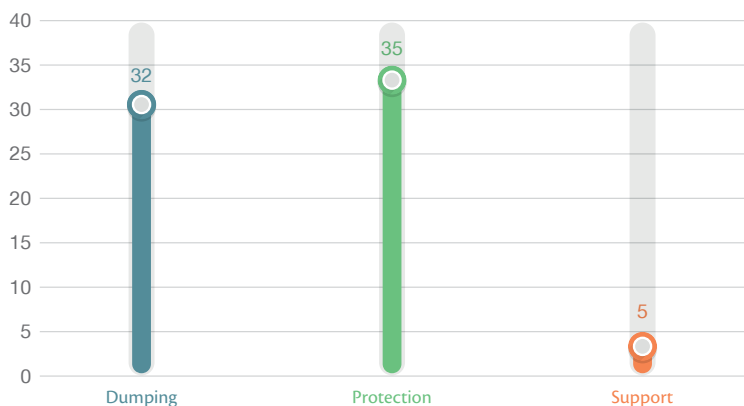
Cumulative number of investigations / duties against the State, towards which the Department took action, distributed according to case as of 31/12/2019

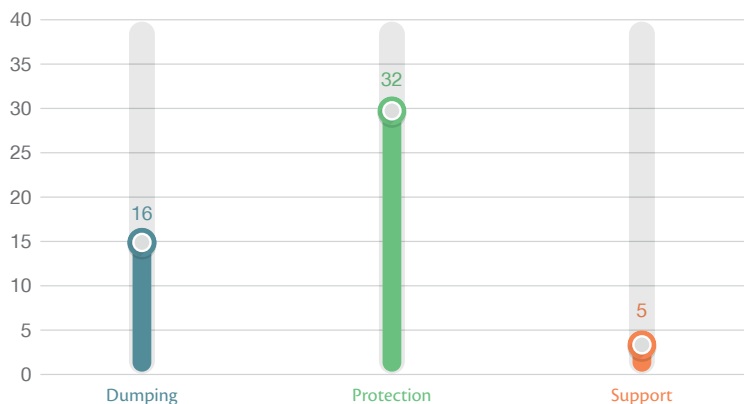
The distribution of the cumulative number of investigations and duties according to the type of investigation as of 31/12/2019

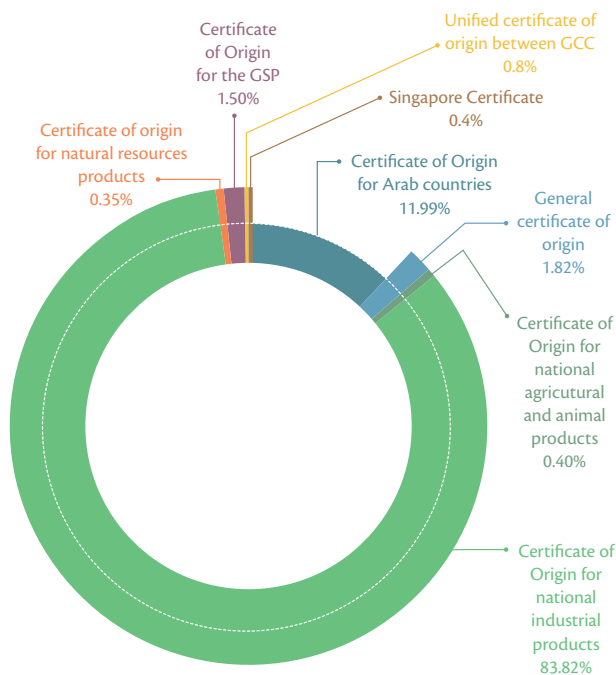

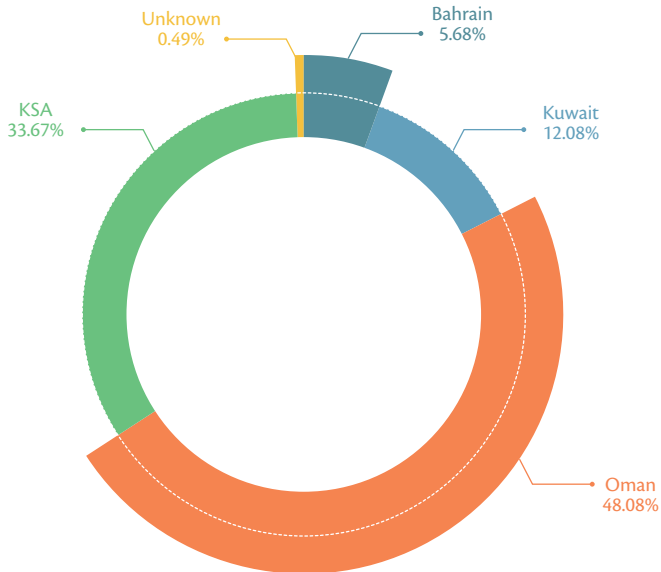

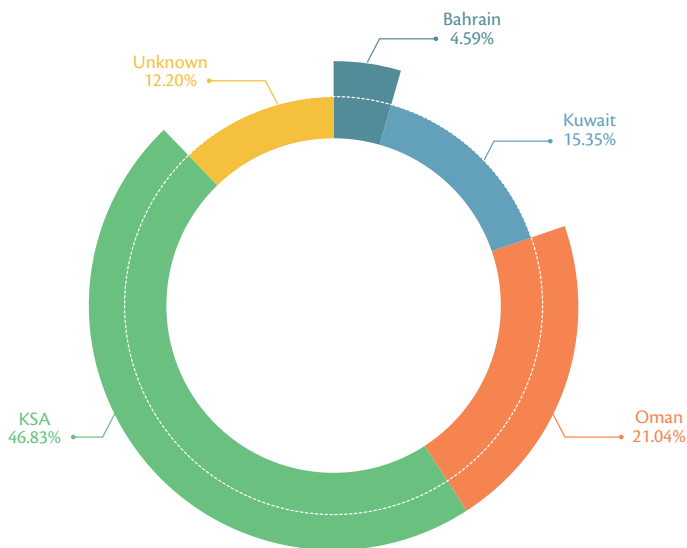
Number of certificates of origin for industrial products distributed according to exporting countries for 2019

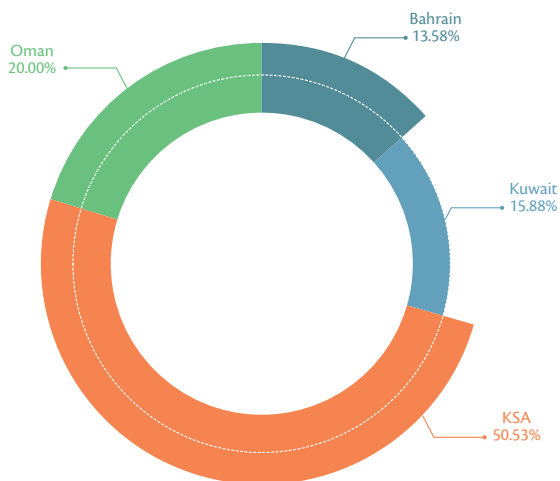

Number of certificates of agricultural and animal products distributed according to exporting country in 2019

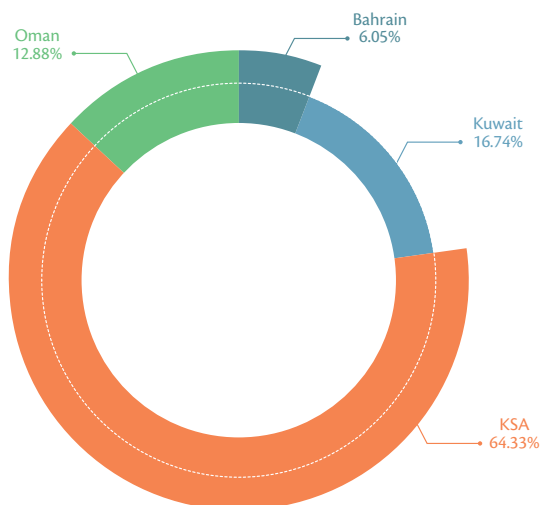
