DHCC comprises two phases. The 4.1 million square feet Phase 1 in Oud Metha is dedicated to healthcare and medical education. Phase 2, which occupies 19 million square feet in Al Jadaf and overlooks the historic Dubai Creek, is dedicated to wellness. DHCR is responsible for ensuring compliance and enforcement of international quality standards for clinical and non-clinical facilities. It also oversees the licensing of all healthcare professionals, educators and operators, and the setting and maintenance of international best healthcare practices within DHCC.

Licensing procedures	Dubai HealthCare City Authority license issuance is done online through the Masar portal and is divided into two stages: • Initial Application • Commercial License Application Initial Application: 1-Client selects the leasing option by booking the unit either through DHCC Leasing or Private owned buildings 2- Client submits online application with the required documents, 3 proposed names for obtaining provisional approvals (document requirements depends on type of legal framework). 3- R&L team reviews the business plan and does the name reservation in DED trade name portal. Individual company members are sent for security check. 4- After receiving the approvals, provisional approval letter is issued with applicable terms and conditions.

	5- In case of any changes to company management members after the issuance of provisional approval, the security check is done again.
	License Application: 1-Client proceeds with signing the final lease agreement based on the provisional approval and pays registration and license fee. In case of FZ-LLC, client proceeds with share capital deposit in the bank account. 2- R&L team will review the documents, and upon share capital deposit, individual company members will sign the legal documents in front of DHCR officials. In case of corporate entity, the documents have to be notarized and attested up to UAE embassy. 3- R&L team will review legal documents, and issues draft MOA & AOA to be signed by customer. 4- Up on receive of signed MOA & AOA, R&L team will proceed with issuance of company constitutional documents such as Certificate of incorporation, commercial license, Company commercial registry and Signed MOA & AOA by registrar.
