Establishing, administrating and developing the nonfinancial Industrial, commercial and service duty free zones on lands granted or dedicated to the company by the government, pursuant to plans approved by the Executive Council. These zones enjoy independent corporate status but are administratively affiliated to Abu Dhabi Ports.  To this end, the authority establishes and issues the necessary regulations and instructions for operations and management of these duty-free zones and for registering firms therein. Moreover, it sets and collect charges for registration and incorporation of firms and for leasing out lands, buildings, or offices spaces to them in addition to supplying the services required for such firms. The authority also recruits Staff necessary to administer these zones.
